

# Honorary Secretary's Report Proceedings of the Statistical and Social Inquiry Society of Ireland One Hundred and Seventy-Sixth Session: 2022/2023

## First Meeting

The first ordinary meeting of the 176<sup>th</sup> session of the Statistical and Social Inquiry Society of Ireland was held at 4.30pm on Thursday 27<sup>th</sup> October 2022, online and at the Merrion Room of the RDS. The meeting opened with society business, including some introductory remarks by the new Society President, Patrick Paul Walsh. There then followed a paper entitled "When worse is better: Economic policy making in the two Ireland's of the mid 1950s' Dr Esmond Birnie and Dr Graham Brownlow." The proposal of the vote of thanks was made by Frank Barry, which was seconded by Ciarán Casey.
