Climate change legislation passed

The Climate Action and Low Carbon Development Bill 2015 successfully passed through both houses of the Oireachtas last week. It will now be referred to the President for signing, and will be passed into law shortly.

This is the first official legislation by an Irish Government to deal with the issue of climate change. Under the Bill, a National Expert Advisory Council on Climate Change will be established. It will be chaired by Prof. John Fitzgerald. It will also introduce National Mitigation plans every five years that will outline measures for the reduction of greenhouse gas emissions in the country, and National Adaption Frameworks every five years that will outline the ways in which different sectors and local authorities can adapt to the effects of Climate change.

This comes the same week as Irish officials attend COP21, the UN Climate Summit in Paris (running from 30 November to 11 December). As Oisin Coughlan of Friends of the Earth stated in his article earlier this year, he doesn't believe Ireland are on-track to meet our 2020 targets, despite already talking about our 2030 targets. He will be attending the summit with hopes of the Irish Government making commitments and keeping them.

Section 37 to be amended

In a joint effort between Labour Ministers and the Anti-Austerity Alliance, a Bill was passed through both Houses of the Oireachtas last week. The Bill, the Employment Equality (Amendment) Act 2015 seeks to amend the much-debated s.37 of the Employment Equality Act 1998.

Therein, religious order and institutions run by them were made exempt from the European Equalities Directive 2000. That is, where they felt that the ethos of their organisation could be threatened, they could express bias in the hiring and firing of staff. The legislation stated that such institutions—such as hospitals and schools—"shall not be taken to discriminate against a person [if] ... it takes action which is reasonably necessary to prevent an employee ... from undermining the religious ethos of the institution".

Opponents of the legislation have said that this creates a loophole whereby employers can discriminate on the basis of membership to the LGBTQ community, and further, to those who do not strictly adhere to Christian beliefs. The Anti-Austerity Alliance, in a press release announcing the Amendment's passing, described the Chilling Effect the clause had on employment; this is somewhat akin to the US Military policy of "Don't Ask, Don't Tell".

The new Amendment will stop religious-run institutions discriminating against staff based on a differing of beliefs.

Low Pay Commission seeking submissions

After the recommendations of the Low Pay Commission were taken into account for Budget 2016, the independent body is about to set to work on its new round of considerations.

On Friday, 4 December, Minister for Business and Employment, Ged Nash TD, opened the call for submissions from interested parties on the topics that the Commission will examine. These topics will be: sub-minima rates for young workers, preponderance of women on the minimum wage, and also a general review of the minimum wage.

While the LPC's recommendation to raise the National Minimum Wage by 50c, to €9.15/h, was accepted and written into Budget 2016 (coming in to effect on 1 January 2016), the Minister asserts that there should be ongoing, annual reviews of the rate, to ensure that the lowest-paid members of society receive fair compensation. New issues—such as the preponderance of women on minimum wage and the reasons for this, and whether or not the levels of sub-minima pay for young workers are appropriate—will be investigated. Women represent the majority of people on the minimum wage. Depending on age and length of time in work, young workers can be paid between 10–30% below the Minimum wage. Therefore, these issues are key.

If you would like to make recommendations or submissions on these issues, the closing dates for submissions are: Friday, 8 January 2016 for Sub-minima rates and Friday, 11 March 2016 for review of the National Minimum Wage and for the reasons for the high volume of women on minimum wage.

Tenants given new rights under Bill

A Bill that aims to help the precarious position of tenants in the country has passed all stages in both Houses, and has been passed to the President to be signed in to law.

The Residential Tenancies Bill will provide sureties to both tenants and landlords. The following measures are supplied within:

- As previously outlined, rent prices will only come under review every two years. Anyone whose rent went up in 2015 will not have to face such a hike until 2017.
- The legislation also puts some responsibility on the landlord in telling their tenants about their rights.
- Deposit Protection will be introduced. The PRTB will now take deposits, with the consent of both parties, and repayment of such shall be dealt with by them. This will minimise the amount of disputes the PRTB sees regarding deposit retention.
- Statutory Declarations should now be supplied by landlords who wish to sell their house, or give it to a member of family. If this sale does not go through, the landlord can be liable.
- Rent arrears will now be dealt with in District Courts, not Circuit Courts, making it cheaper for landlords to bring cases about rent.
- Housing Assistance limits will be increased in some major cities.
- Tax breaks of 100% mortgage interest relief will be given to landlords who take in tenants on Housing.
 Assistance Payments or rent supplements for a period greater than three years.
