Spring/Summer Legislative Programme launched

On Tuesday 17 January, the Government launched their Legislative Programme for the Spring/Summer 2017 session.

This programme is divided into six sections; those sections, and the number of items therein are as follows:

Section 1. Government Bills to be published by July 2017 (31)

Section 2. Bills for Pre-Legislative Scrutiny (33)

Section 3. Bills that every "Department plans to introduce" longer-term (69)

Section 4. Published Bills that are currently before the Oireachtas (27)

Section 5. Acts passed by the Government since establishment (18)

Section 6. Bills published by the Government since establishment (28)

In a press release by An Taoiseach, he stated that the 31 Bills that have been prioritised and the 27 currently before the Oireachtas "will ensure that this Partnership Government will make progress on legislation across a wide range of issues as it enters its second year in office, in the first half of 2017".

This comes after a Government defeat in the Dáil concerning a motion to establish a compensation fund for tillage farmers; this motion was proposed by the Opposition. The Government were also saved from a second defeat when An Ceann Comhairle, Sean Ó Fearghaíl, voted with Government
