Think of interventions in courts with Children as a 'Civic Engagement' Issue

- Political Fair Attention
- Social Forms with sibling ext family community involvement – retaining a connection
- Economic Cost Effective
- Moral A Right

- REAL Value of a 'week in week out' family school and community involvement For children in care system— informal social support — court function?



Child Protection as Civic Engagement

- Community action to support and protect local children Communities That Care (Hawkins 2009) – implementable actions
- Treat the witnessing of physical emotional abuse willful neglect on a par with injury in a traffic accident
- UNESCO Learning from Zambia leadership for girls at risk! (McArdle 2012 – Redmond et al in paper)
- Requires a partnership between services and communities – heretofore not tried!!! A preventive role for family courts? – supervision orders used in an innovative way?


Core to Family Success for Children

- Consistent parents and family (or replacement)
- Predictable life!
- Warmth in relationships
- Ample Resources
- Access to Education and Welfare services if needed
- 'Outcomes' for wellbeing

Innovative methods by court system

- Consultation with Children/families
- E.G. Family Group Conference a potential not fully exploited (Connolly, 2009)
- Home care sharing placement options at home during week in care at weekends
- One day a week rule!
- Supervision orders
- Giving the Family 25% of the costs to state Italy Trial
- Use of Family Mediation at an earlier point
- Unsatisfied Dissatisfied issue (Gardner 2006)



- Major Question around Case management v direct work – common sense to act now!




